#### PURPOSE

ProPEAT Fertilizer N-Less Green with Sphagnum Peat is a granular fertilizer for use in turf and ornamentals. The product is available in homogenous granular prills each containing Iron, calcium, magnesium, and sulfur. The granules break up evenly in the soil providing a uniform release of nutrients. This product works equally well in wet and dry climates.

#### DIRECTIONS FOR USE

Apply ProPEAT N-Less Green at 150 lbs/acre. (3.44 lbs Per1,000sq ft.) Apply as needed based on soil test or according to recommendations in your nutrient management plan. Consult your area ProPeat distributor for specific recommendations.

Immediately after application, apply a minimum of 0.2 inches of water to disperse the granules. Watering in this product will help disperse granules and help move nutrients into the soil.

#### FOR FLORIDA APPLICATIONS
