GENERAL INFORMATION

Carbon90Plus 13-5-8 is a peat based granular fertilizer for use in turf and ornamentals. The product is available in homogenous granular prills each containing NPK and sulfur. The granules break up evenly in the soil providing a uniform nutrient release. Carbon90Plus 13-5-8 works equally well in both wet and dry climates.

DIRECTIONS FOR USE - PROFESSIONAL USE ONLY

Apply Carbon90Plus 13-5-8 at 200 lbs/acre. Apply as needed based on soil test or according to recommendations in your nutrient management plan. Consult your area ProPeat distributor for specific recommendations.

Immediately after application, apply a minimum of 0.2 inches of water to disperse the granules. Watering in this product will help disperse granules and help move nutrients into the soil.
